Solicitations and Responses

Respond to RFQs and RFPs right in ASSIST. The ASSIST Solicitation functionality allows GSA to post opportunities to prospective contractors in the same system where the Awards will be issued. And it allows you to submit Responses (both quotes and proposals) in a more streamlined manner with finer granularity down to the Line Item level.

Award and Administration

Bilateral signatures, modifications, invoices, collaborations - everything you need to work with GSA throughout the life cycle of administering the Award. All in one place.

Identify a Point of Contact and as many Alternates as necessary to participate in the administration. Track modifications to the award, submit invoices for payment, participate in ASSIST Collaborations (such as the submission of Reports, Deliverables, Resume Acceptances, Consents to Purchase, and more).
