- Government-wide Acquisition Contracts (GWACs), and
- Multiple agency multiple award

# <u>Q&A</u>

## Is ASSIST going to replace GSA eBuy?

No, ASSIST 2.0 is separate from GSA eBuy. ASSIST will be generating solicitations primarily for AAS. eBuy will continue to be used by GSA going forward.

#### Will GSA eBuy combine into ASSIST?

Initial implementation of ASSIST 2.0 will not have an integration to eBUY. It may be done after initial deployment in future enhancements.

#### If not replacing or integrating eBUY, why are there two systems to submit proposals?

eBUY is a FAS wide application. ASSIST is specifically for Assisted Acquisitions. The decision on which system to use for solicitations will be made by the acquisition team.

## Are the solicitations posted via ASSIST also posted in eBUY?

If they are posted via ASSIST, then they will not be posted in eBuy.
